

RISK ACKNOWLEDGMENT & WAIVER

PLEASE READ CAREFULLY: This document affects your legal rights.

1. Risk Acknowledgment

I understand that the activities offered by Markus Beck — including mountaineering, rock climbing, ice & mixed climbing, glacier travel, via ferrata, skiing, ski touring, ski mountaineering, trekking, tandem paragliding, canyoning, and transportation by vehicle or helicopter — involve inherent risks that cannot be eliminated and may result in serious injury, property damage, or death.

These hazards include, but are not limited to: steep or unstable terrain, cliffs, rockfall, icefall, cornices, avalanches, crevasses, slips, falls, equipment failure, severe weather (lightning, wind, snow, temperature extremes), altitude sickness, hypothermia, frostbite, heat exhaustion, dehydration, and delayed or unavailable emergency medical assistance in remote environments.

2. Safety & Participation

I agree to follow all instructions, use safety equipment as directed, and accept that Markus Beck has final authority on safety decisions and route choices. Markus Beck reserves the right to remove any individual whose behavior or condition compromises safety, and may cancel or modify activities for safety reasons. No refund is provided in such circumstances and all extra cost if any are the responsibility of the participant.

3. Medical Disclosure & Responsibility

I confirm that I have disclosed all relevant medical conditions and am responsible for bringing and managing required medications. I accept full responsibility for obtaining and maintaining personal insurance, rescue insurance, and travel insurance for injuries, property damage, loss, or travel plan changes. I authorize Markus Beck to obtain emergency medical treatment on my behalf and understand I am responsible for all costs associated with treatment, evacuation, and rescue operations.

4. Third-Party Services

I acknowledge that Markus Beck is not responsible for third-party providers of transportation, accommodation, or other services, nor for expenses, delays, or losses from circumstances beyond control.

5. Waiver & Release of Liability

By signing, I voluntarily assume all risks associated with these activities. I release, waive, discharge, and covenant not to sue Markus Beck from any liability, claims, demands, or causes of action arising from any loss, damage, or injury, including death, sustained while participating. I agree to indemnify and hold harmless Markus Beck from any loss, liability, damage, or cost incurred due to my participation.
